

## HISTORY OF THE SIXTY-SECOND NAVAL CONSTRUCTION BATTALION

Mobile Construction Battalion 62 -- like MCBs 40 and 58 -- derived its numerical designation from a Naval Construction Battalion that gained World War II fame. The original NCB 62 was commissioned on December 30, 1942, at Davisville, Rhode Island. After two short months of training the Battalion left for its embarkation point, Port Hueneme, California. Lieutenant Commander Rudolph Y. Taggart was the outfit's Officer-in-charge.

On March 24 NCB 62 boarded the transport ship MATSONIA, bound for Pearl Harbor.

Until early September 1944 the Battalion stayed in Hawaii, constructing repair and servicing facilities for the Pearl Harbor Submarine Base, Completing a dike at Loko Eo, building landing craft facilities at Waipio Point, and much more. Over two million yards of fill material were moved on the Loko Eo dike alone.

A small detachment from NCB 62 went to the Island of Angaur, in the West Carolines, to set up pontoon docks. These men became the first of the Battalion's Seabees to encounter the enemy when they were fired upon by Japanese snipers.

In September of 1944 the Battalion finished its work in Hawaii and underwent two weeks of jungle training at Sweetheart Valley, Oahu, in preparation for the big job ahead -- Iwo Jima. NCB 62 then moved to the Island of Maui for two months of amphibious, marine and weapons training.

The Iwo Jima task force left Saipan on February 16, 1945. The ships carrying NCB 62 all got safely through to beach their cargoes of men and machines despite kamikaze raids by the Japanese. The first shipload was ashore at 10 p.m. of D-Day (February 19) plus five. By 2 a.m. of D-Day plus seven, the whole Battalion was ashore.

The Japanese attacked with mortars that night.

The Battalion's job at Iwo Jima was to get three bombed-out Japanese airfields back into shape as quickly as possible. The Seabees did just that -- heavy equipment operators were at work on the first airfield, clearing off wrecked Japanese planes and filling bomb craters the first day the Battalion was on Iwo Jima.

The dozer drivers had to duck from snipers' bullets, fight off banzai attacks and jump for cover every time the Japanese mortars opened up on them. But work on the Number One airfield went on day and night. On D-Day plus 12, work was begun on the Number Two airfield.

The Seabees spent a total of five months improving Central Airfield. When they were finished, they had moved over three million yards of earth and were in possession of the longest airstrip -- 5225 feet -- in the western Pacific.

On V-J Day, August 14, 1945, NCB 62 was among 13 Construction Battalions and three Special Battalions awaiting assignment to Japan, where they were to aid Naval forces at various cities.

The 62nd Naval Construction Battalion was inactivated on September 15, 1945, at Yokosuka, Japan.



## COMMANDING OFFICER

COMMANDER WILLIAM J. RICHESON, CEC, USN

Commander William J. Richeson was born in Atlanta, Georgia, on 27 January 1924. He took two years of pre-medical courses at Georgetown University before enlisting as a Naval Aviation Cadet in December 1942. In May 1944 he was commissioned as a Naval Aviator. He served with Bombing Squadron 95 until his separation in December 1945.

He then went back to college at the Catholic University of America, Washington, D. C., and was graduated in 1949 with a bachelor's degree in architectural engineering. From that time until his recall to active duty in November 1950, he was an associate architect with E. H. Glidden Jr., of Baltimore, Maryland.

Since 1950, Commander Richeson has served as Training Battalion Executive Officer, Port Hueneme, California; Assistant Planning and Design Officer, Area Public Works Office, Mariana Islands; and Assistant Public Works Officer, Naval Air Material Center, Philadelphia, Pennsylvania.

In 1956-57 he attended Rensselaer Polytechnic Institute and received his Bachelor of Civil Engineering degree in August 1957.

Following graduation, he served as Public Works Officer at the Naval Auxiliary Air Station, Saufley Field, Pensacola, Florida; ROICC, Iwo Jima; Assistant Operations Officer and Operations Officer, Construction Battalions, U. S. Pacific Fleet; Public Works Officer, Naval Supply Depot, Mechanicsburg, Pennsylvania; and Assistant for Facilities Management, Facilities Engineering Command, Northwest Division, Seattle, Washington.

Commander Richeson is married to the former Rosemary Anne Kelso of Linthicum Heights, Maryland. They have seven children; Deborah, 14; Stephen, 12; Elizabeth, 10; Margaret, 9; Pamela, 8; Laura, 4; and William Jr., 1.
